Unfinished Business

Community Service Amendment

Each member of every IFC member organization will be required to complete 5 hours of community service each semester and report their hours at www.volunteeryourtime.org. Each fraternity will be held responsible for this community service commitment (Ex. a fraternity with 50 members will need to complete 250 hours of combined community service) for 75% of its associates. Any member organization that fails to meet the required hours will be fined \$5 per hour missed, made payable to the IFC. A maximum fine of 10% of **75% of** the organizations members will be in place, therefore an organization with 50 members will have a maximum fine of \$93.75 (50 members * 75% of members * 5 hours/member * \$5/hour * 10% maximum.) All fines collected due to this amendment will go to the IFC budget to help fund IFC service projects and/or philanthropic donations approved by the IFC.

Each associate of the member chapter will be required to complete 5 hours of community service and log their time on the website www.volunteeryourtime.org.
